Those in attendance were aware that the **October 14, 2021** regular meeting of the Commission was being recorded.

Guest Presentation – Lauren Hughes

Last time Lauren presented before the Social Services Commission was February 2020, just before the building was closed to the public due to Covid19. Enrolling seniors in Medicare and Social Security takes up more of her job because people are retiring later, and laws have become more complicated. In addition, Social Security enrollment is done entirely online. Lauren is the food pantry point person. Pre-pandemic, volunteers manned the food pantry. Increased gift card donations offset some of the extra work staff took on for the food pantry. The Wilton community is overwhelmingly generous and pantry shelves are never empty. SNAP (replaced the old food stamp program) doesn't cover personal care items and paper goods, but the food pantry has funds to help cover this gap. Lauren cited many community groups that donate their time and resources to the food pantry during major holidays and throughout the year. In January, she happily sends many 'thank you' notes.
