## BOARD OF SELECTMEN REGULAR MEETING MONDAY, MAY 6, 2013 MEETING ROOM B, WILTON TOWN HALL

Mr. Brennan called the meeting to order at 7:30 p.m.

## A. Consent Agenda

Upon motion by Mr. Dubow, the consent agenda was approved as follows (Mr. Clark abstained as he was not present at the 4/1/13 meeting; Mr. Hoffstatter and Mr. Saxe had not yet arrived):

The Board of Selectmen expressed their appreciation for these generous gifts.

## B. Discussion and/or Action

## 1. Stay at Home in Wilton - Presentation

Mr. Dick King gave a presentation on the Stay at Home in Wilton program (attached), noting that this program supports an independent lifestyle for Wilton

seniors so they can age in place. The Selectmen expressed that they highly support Stay at Home. Mr. Dubow suggested inviting a high school student to be an advisory member of the board.

## 2. <u>Safe Rides Proposal - Presentation</u>

Mr. Mike Safko and his daughter, Lauren Safko, gave a presentation on a proposed Safe Rides Program for high school students in Wilton (attached). This type of program has been in use in Ridgefield, Darien and Westport for many years, and was once used in Wilton in the mid-80s. The First Selectman will speak to Dr. Richards, Schools Superintendent and Police Chief Lombardo to get their thoughts.

## 3. CT Clean Energy Program – Pledge for Continuing Participation

Mr. Bruce Hampson and Ms. Debra Thompson-Van explained the Clean Energy Communities Program (attached). To date, the Town has received five Kw Solar Systems at Wilton High School, valued at \$39,600; a \$4,000 grant for the 2010 Go Green Festival; and, \$2,000 for the 2011 Festival. The Town is being asked to sign the Clean Energy Communities Municipal Pledge to seek to reduce municipal building energy consumption by at least 20% by the end of 2018. Ms. Thompson-Van pointed out that the changes that the State has approved in the pledge were changes intended to utilize work Wilton had already done, i.e. establishing a baseline and Plan by utilizing the SBS report from 2010/2011. There were no general changes nor changes in the R&Cs.

After some discussion, Mr. Clark moved to authorize the First Selectman to sign the Pledge contingent on final review and approval of the Town Attorney. Motion seconded and carried: 4 YES – 1 ABS. (Saxe)

## 4. 3Degrees Purchase and Sale Agreement - Renewable Energy

Mr. Dubow moved to authorize the First Selectman to sign the 3Degrees Purchase and Sale Agreements #5139 and #5143. Motion seconded and unanimously carried.

## 5. Recreational Trails Grant Application

Mr. Clark moved to approve the grant application for state funds in the amount of \$1,280,596 for the Recreational Trails Program – Norwalk River Valley Trail. Motion seconded and unanimously carried.

## 6. Appointment of Comstock Building Committee

Mr. Brennan moved to appoint Judy Zucker, Bruce Hampson, David Hapke, and Mark Ketley as members of the Comstock Building Committee. Motion seconded and unanimously carried. In addition, Steve Pierce, Director of Parks and Recreation and Cathy Pierce, Director of Social Services will serve on the committee, with Liz Doty filling as Ms. Pierce's alternate. There will be further appointments made at the next meeting.

## 7. Miscellaneous Other Business

Ms. Dennies and Mr. Nerney, Town Planner, are requesting that they be authorized to retain the services of JM Local Government Consulting to interface between the land use departments and New World in order to implement the necessary processes for Land Use, Building Department and Health Department permitting processes, etc. The cost will be \$100/hour up to \$10,000. Mr. Clark moved to authorize the First Selectman to sign the Agreement with JM Local Government Consulting. Motion seconded and unanimously carried.

## C. Public Comment - None noted

## D. Reports

1. <u>First Selectman's Report</u> – From 5/13/13, to 5/21/13, the CT DOT will be resurfacing Route 33 from Signal Hill North to the Ridgefield town line.

The Town Attorney is working on finalizing the Library Agreement with the town. Once completed, it will be sent to all Selectmen before being placed on a future meeting agenda.

## 2. Selectmen Reports:

Mr. Dubow — The Miller Driscoll Building Committee held its first meeting, electing Mr. Bruce Hampson as Chair and Ms. Karen Birck as Vice Chair.

Mr. Clark – Friends of Ambler Farm are \$50,000 away from meeting their budget commitment to the Town. They are making good progress and expect to be under the planned expenditures.

Mr. Hoffstatter - Trackside held their big annual fundraiser, which was very successful. The Go Green Festival this past weekend was also very well attended.

Mr. Saxe – No report

E. Adjournmept – Having no further business, the meeting was adjourned at 9:25 pm.







Dear First Selectman Brennan,

As you suggested, the following is a brief summary of our proposal to re-establish SafeRides in Wilton for the upcoming 2013-14 school year.

## Our Background

My wife Susan and I have lived in Wilton since May 1995, We are raising three daughters.. Christen (20 at college), Lauren (17 junior at WHS) Crickett (10 at Cider Mill). Susan practiced law in NYC for 8 years before moving here. I recently retired after working in finance in NYC for 25 years. While on vacation during winter break this year Lauren (a newly licensed driver) and I were

discussing the dangers of drinking and driving. She mentioned that Ridgefield, Darien, Westport and other local towns have a program which provides teens with rides home on Friday and Saturday nights during the school year. With the strong support, enthusiasm and involvement of both Lauren and Susan we are hoping to have Safe Rides in Wilton by September 2013.

## Due Dilligence

I have met with Mara Kent (203.470.6297) who currently runs the very successful program in Ridgefield and spoke to Patti Ballard who ran the program (with her husband) in Ridgefield for nine years, They have both pledged their full support in every way possible. Mara has already sent a complete set of all documents used in running the Ridgefield program. I have contacted Isaac Levy in Westport (one of the national founders of Safe Rides USA). He has reactivated the Wilton Safe Rides web site and like the others could not be more helpful and enthusiastic about our plans.

## History of Safe Rides in Wilton

I understand that Safe Rides had a successful program in Wilton in the mid 1980s. But due to a lack of continuity in parental and student support the operation disappeared a few years later. In 2011 two WHS students tried to reestablish the service and had received approval to run the weekend operation from space at Trackside. Unfortunately, the most recent efforts were unsuccessful.

The Program

Although the service varies from town to town, the mission of SafeRides is to provide transportation to teenagers in Wilton who are either unable or incapable to getting safely home from a specific location.

Details:

- 1) Hours are from 9:30pm-2:00 am on Friday and Saturday nights while school is in session
- 2) Each car is manned by two individuals (one male/one female)
- 3) All passengers are driven home only... no other destination permitted
- 4) Identity of passengers remains anonymous
- 5) 7 two-man teams and one adult supervisor manning the operation each night
  - 6) Insurance is provided by Boy Scouts of America
- 7) Funding- Each volunteer and board member pays a \$25 membership fee. The money collected is used to fund insurance, pizza and all other ancillary costs. THE ENTIRE PROGRAM IS SELF-FUNDED.

NO REQUESTS FOR FINANCIAL AID WILL BE MADE TO THE TOWN OF WILTON.

Progress So Far

I have met with Mark Ketley, Executive Director at Trackside. He is very supportive of the program and will likely allow us to run the operation out of a spare office at the Trackside facility. He suggested I reach out to you and other Selectmen for your input.

## Success of Local Programs

Despite the mixed track record of Safe Rides in Wilton, other towns have been very successful. The programs in Westport (30 consecutive years), Ridgefield (29) and Darien (31) are so well established that they have become part of the fabric of the local community. In Ridgefield, for example, the Safe Rides program has provided, on average, between 400-500 rides a year to teens. Danbury Hospital's ER has made several unsolicited donations to Ridgefield as acknowledgement of the positive impact of the program.

We look forward to answering any questions at the Board of Selectmen meeting this Monday night.



# Mission

To provide free rides to intextest impaired choices and seek alternatives to driving while circumstances. The program gives teens the information they need to make informed students and/or teens who are rendered incapable of transportation due to other impaired.

# Logistics

- Supervised by an adult volunteer, approximately 6-7 2-person co-ed teams will provide rides home to SafeRides will operate from 10 PM to 2 AM on Fridays and Saturdays during the school year. fellow students.

- 7 of 10 student board members selected. 1st meeting scheduled for late May.
