 2020 CT Neighborhood Assistance Act Tax Credit Program Applications – Sarah Gioffre Ms. Vanderslice noted that a Public Hearing was just held on the 2020 CT Neighborhood Assistance Act Tax Credit Program Applications.    Community Assistance Fund and other programs).

Mike Conklin, Director Environmental Affairs reviewed the attached 2020 Deer Management Plan and responded to questions. - FEMA and State Reimbursements Anne Kelly-Lenz

Drop box only service is available at Town Hall. Efforts continue to move additional services, including licenses and permits online.
