Ms. Vanderslice provided an update on two COVID outbreaks in town. One, occurred at SSND. She expressed the Town's gratitude to the CT DPH COVID-19 Response, which arrived Monday to assist SSND. The second occurred among Wilton High School. Updates are being issued by the Health Department. She recognized the entire Wilton vaccine team. All,

The Governor is expected to soon issue an executive order, which will allow municipalities to deviate from the budget process and timeline in their Charter. The order is also expected to allow for no town meeting, a hybrid town meeting or an in-person town meeting and COVID excused absentee voting.

I was hoping it might be released by today. The Charter requires we set the ATM date by Feb 1. Just in case the EO isn't issued, will be recommending we set a date tomorrow. I don't like the idea of leaving it until the very last day. Once the EO is issued we can change the date.

I met with Jeff, Debbie, Kevin and Anne. We have agreed on a recommendation for a revised schedule once the EO is issued.

I have attached the proposed schedule that meets Charter requirements should the EO not be issued.
