 - 1. NRVT Cooperation Agreement Doug Lomonte
 - Ms. Vanderslice introduced Doug Lomonte of Berchem Moses to review the NRVT Cooperation Agreement. He noted that the agreement is a 3-party agreement between the Town of Wilton, City of Norwalk and Friends of the Norwalk River Valley Trail. The agreement describes the rights and obligations of the Town, the City and Friends of NRVT with regard to the section of the trail funded by a shared grant between the two municipalities. He noted the agreement was drafted in cooperation with counsel for Norwalk and passes legal review. After discussion and review, motion for the First Selectwoman to execute the document moved by Ms. McFadden, seconded by Mr. Tartell and carried 5-0.

Housing and Zoning Proposed Bills

Proposals Utilizing Taxes/Grants to Prioritize Affordable Housing

- <u>SB 171</u> creates a "mansion tax" on homes with an assessed value over \$300,000, or market value over \$430,000.
- <u>SB 172</u> would establish a statewide tax on commercial and residential property to encourage affordable housing as defined by 8-30g. The tax has a "sliding scale" which reflects how far a town is from the required 10%.
- <u>SB 808</u> would property tax surcharge in some municipalities to fund affordable housing.
- <u>SB 712</u> would proportion school building grants to the level of affordable housing in a municipality.
- <u>HB 6240</u> provides 100% PILOT for State Housing Authority properties.

Housing and Zoning Proposed Bills Local Control

Pullbacks on local control

- <u>SB 804</u> is the Desegregate CT platform.
- <u>SB 551</u> and <u>SB 554</u> would require towns to permit a greater density of housing within a 1/2 mile of a public transit station than otherwise permitted by the town.
- <u>HB 5682</u> could require allowing duplexes in all single family zones.
- <u>HB 6287</u> would allocate affordable housing needs on a regional basis, set municipal goals, and create and enforce "fair share" plans.
