

A. Call to Order

Miss Vanderslice called the meeting to order at 8:02 PM

B. Executive Session

Motion made by Mr. Dubow at 8:02 PM, seconded by Ms. Bufano and unanimously carried to go into Executive Session and invite Sarah Taffel to discuss Collective Bargaining Update and Town Counsel Ira Bloom for Discussion of Possible Purchase of Real Estate Proximate to Wilton Center.

- C. Discussion and/or Action
 - AFSCME Collective Bargaining Consideration of Approval of Tentative Agreement and Possible Vote Motion made by Mr. Clune to approve the Tentative Agreement as discussed, seconded by Mr. Kaelin and unanimously carried.

3. Local 2233 International Association of Fire Fighters, AFL-CIO Grievance Ms. Vanderslice opened the subject for discussion by the Board of Selectmen based on what was presented at the previous Board of Selectmen meeting.  Field to Hurlbutt Field.
- d. Gift of Two Bleachers from WHS Tennis Boosters Mr. Clune noted that the bleachers can be moved wherever needed but that they are primarily meant to be kept at the tennis courts. Motion made by Mr. Dubow to accept the gift of two bleachers from WHS Tennis Boosters subject to the approval of Steve Pierce, Parks and Recreation Director. Motion seconded by Mr. Clune and unanimously carried.

6. Millstone Farm – Request to Modify Conservation Restriction Ms. Vanderslice noted that she received a letter from Casey Healy withdrawing the request to modify the Conservation Restriction and that it was withdrawn from Planning & Zoning as well.
