BOARD OF SELECTMEN PUBLIC HEARING & REGULAR MEETING MINUTES Monday January 8, 2024

A. Call to Order

Ms. Boucher called the Meeting to order at 7:00pm.

Ms. Boucher asked for a motion to add 2 items to the agenda under Appointments/Reappointments to add appointment to Inland Wetlands and appointment to Police Benevolent Association. Motion moved by Ms. Healy, seconded by Mr. Tartell and carried 5-0.

B. Executive Session

Interview EDC Candidate

Ms. Boucher asked for a motion to enter into Executive Session at 7:03pm to interview candidate for EDC and invite candidate Tom Shimko. Motion moved by Ms. Healy, seconded by Mr. Cole and carried 5-0.

Out of Executive Session and back in regular session at 7:38pm.

C. Public Comment

Sara Curtis of Cannon Rd commented and gave the BOS an update on behalf of the residents of Cannon Rd regarding their traffic concerns. Ms. Boucher noted Ms. Curtis' concerns and noted she would follow-up.

D. Consent Agenda

Motion moved by Mr. Cole, seconded by Mr. Tartell and carried 5-0 to approve the Consent Agenda as follows:

E. Discussion and/or Action

- Reaffirmation of Wilton Civility, Respect and Understanding Proclamation
 Ms. Boucher reviewed the towns Civility, Respect and Understanding Proclamation. Ms.
 Boucher was not a board member when the proclamation was signed back in January of
 2022 by all board members. Ms. Boucher read the attached proclamation and all board
 members reaffirmed their commitment and once again signed off on the proclamation.
 Mr. Tartell suggested that all town boards/commissions if they choose, be encouraged to
 adopt the proclamation.
- 2. Date Change of Proposed Change to Code of Ordinances Ch.8, Article I, "Sale of Alcoholic Liquor" to May Annual Town Meeting Ms. Boucher noted the Special Town Meeting that was scheduled for January 9, 2024 has been cancelled. She noted the concern that a Special Town meeting may not have the number of voters in attendance required. The board thought it best to move to the May Annual Town Meeting when the number of voters needed would be assured. Motion made by Ms. Healy to change the date from January 9, 2024 to the May Annual Town Meeting. Motion seconded by Mr. Tartell and carried 5-0.

3. Grev House Demolition

Ms. Boucher reviewed the Grey House Demolition with the board, noting the Grey House is located on the Town Hall Property near the Police Station and needs to be removed for the Police Building Project to move forward. She noted that 3 bids were received and recommendation for contract be awarded to the lowest bidder. After further review and discussion, motion made by Mr. Nabulsi to authorize the First Selectman to execute an agreement with Complete Dismantling Services for the removal of the Grey House in the amount of \$15,755 plus the \$400 per load, subject to review by legal counsel. Motion seconded by Ms. Healy and carried 5-0.

4. Proposed Budget Schedule

Ms. Boucher reviewed the proposed budget schedule for 2024 with CFO Dawn Norton providing input. After discussion and detailed review with the board, motion made by Ms. Healy to approve the proposed budget schedule. Motion seconded by Mr. Nabulsi and carried 5-0.

5. Appointments/Reappointments

- Representative to HRRA Matt Knickerbocker for term July 1, 2024-June 30, 2027
 Motion made by Mr. Tartell to reappoint Matt Knickerbocker as the towns
 Representative to the HRRA. Motion seconded by Mr. Cole and carried 5-0.
- Voting Alternate to HRRA Toni Boucher
 Motion made by Mr. Tartell to appoint Toni Boucher as the Voting Alternate to the
 HRRA. Motion seconded by Mr. Cole and carried 5-0.
- Possible Appointments Trackside Board Ms. Boucher noted two appointments to the Trackside Board. Kevin Smith and Forrest Close. After review of the suggested appointments, motion made by Mr. Cole to appoint Kevin Smith and Forrest Close as the BOS liaisons to the trackside board pursuant to Section 3.4 of the trackside bylaws. Motion seconded by Ms. Healy and carried 5-0.
- Possible Appointment EDC
 Motion made by Mr. Nabulsi to appoint Tom Shimko as a member to the
 Economic Development Committee for a two-year term. Motion seconded by
 Ms. Healy and carried 5-0.
- Fire Commission John Hall (Reappointment)
 Motion made by Ms. Healy to reappoint John Hall to the Fire Commission.
 Motion seconded by Mr. Tartell and carried 5-0.

- Inland Wetlands Commission
 - Motion made by Mr. Tartell to appoint Kathy Dhanda as a member of the Inland Wetlands Commission for a 3-year term. Motion seconded by Mr. Nabulsi and carried 5-0.
- Police Benevolent Association
 Motion moved by Mr. Cole to appoint Toni Boucher to the Police Benevolent Association. Motion seconded by Ms. Healy and carried 5-0.
