

# BOARD OF SELECTMEN MONDAY JULY 18, 2016 MEETING ROOM B, WILTON TOWN HALL

## B Discussion and/or Actions

# 1. Energy Grants/Lighting Retrofit Town Hall Campus

Debra Thompson-Van informed the BOS that the Energy Commission had been successful in the ZREC bid they had submitted to Eversource on behalf of the Town. A special meeting may be held to discuss further.

As part of participating in the CT programs the Town has earned a second \$10,000 clean energy grant and \$4,500 renewable energy grant. In analyzing the different projects available one that seemed to make more sense was to go after relamping the Town Hall complex with LED lighting. Ms. Thompson-Van then asked Chris Burney, Director Facilities and Energy Management to further review what the project looks like, the terms around usage for the grant and savings. Mr. Burney gave a handout to the Board of Selectman from the Consultant Firm that reviewed the Town Hall complex and further reviewed the project details. He noted that the project would provide savings in maintenance, savings in operating budget and savings because of inflation. He noted that the handout reflects savings for the cost of operation. Project could start within 2 weeks of contracts being signed. State has asked that complete by end of July. First phase is to ask the First Selectman to sign the two Memorandum's of Understanding which confirm the Town's agreement to accept the \$14,500. Utility company provides a O% interest 48 Month loan which will be repaid out of the bills, bills will reflect the savings and the loan payment. Motion made by Mr. Kaelin to approve the agreements and authorize the First Selectman to sign. Motion seconded by Ms. Bufano and unanimously carried.

## 2. Proposal for Stadium Advertising

Mr. Clune began discussion on looking to sell advertisements at Wilton High School stadium. He noted that monies raised from selling ads, including printed banners visible to the home and guest bleachers, could help pay for replacement of the turf field at the high school.

Mr. Dubow raised the question of who would be responsible for ruling on which ads are appropriate or not and Mr. Kaelin noted that research should include discussion with the Board of Education as well as the Town Planner and Town Counsel before proceeding.

Mr. Clune noted that he would likely form a committee or group to lead the advertising sales efforts at the stadium.

#### 3. August Meeting Date

Ms. Vanderslice noted that she circulated requests for availability for August meeting dates for the Board of Selectmen meetings. Based on responses Ms. Vanderslice suggested cancelling both meetings in August and having one rescheduled meeting for August 8, 2016. Mr. Dubow will be unable to attend the meeting on August 8<sup>th</sup>.

#### 4. Two Rod Hwy-Special Town Meeting Date

Ms. Vanderslice noted that she was waiting to hear back from Planning and Zoning, but that as of now looking at September 19<sup>th</sup> or first weekend in October for the Special Town Meeting. She also noted that there would need to be at least 50 people in attendance at the meeting.

# 5. Appointments/Reappointments

Ms. Vanderslice noted that the Tree Committee has had difficulty achieving a quorum due to vacancies. Jackie Algon was recommended by the Conservation Commission for one of their assigned seats. She asked that a motion be made to appoint Ms. Algon to the Tree Committee. Motion made by Mr. Kaelin to appoint Jackie Algon as the Conservation Commission appointee to the Tree Committee. Motion seconded by Mr. Clune and unanimously carried.

Ms. Vanderslice noted that the Board of Selectmen neglected to appoint Mr. Clune and Mr. Kaelin to the Study Committee at the last meeting. Motion made by Mr. Dubow to appoint Mr. Clune and Mr. Kaelin to the Study Committee. Motion seconded by Ms. Bufano and unanimously carried.
