BOARD OF SELECTMEN SPECIAL MEETING Wednesday June 28, 2023 Held Electronically

A. Call to Order

Ms. Vanderslice called the meeting to order at 4:00pm.

B. Public Comment None.

- C. Discussion and/or Action
 - DOT Dial-a-Ride Grant Application Parks & Rec Matt Knickerbocker
 Mr. Knickerbocker reviewed the proposed application for a DOT Dial-a-Ride Grant for funds to assist with the operating costs of the Dial-a-Ride program. After discussion and review motion moved by Ms. Healy to have the First Selectwoman sign and submit the grant application. Motion seconded by Mr. Tartell and carried 5-0.
 - Renewal Agreement State Partnership Plan 2.0 Matt Knickerbocker Mr. Knickerbocker reviewed the Renewal Agreement State Partnership Plan 2.0. After review and discussion, motion moved by Mr. Cole to authorize the First Selectwoman to authorize the Renewal Agreement for the State Partnership Plan. Motion seconded by Ms. Healy and carried 5-0.
 - Contract Renewal CIRMA Liability LAP Matt Knickerbocker Mr. Knickerbocker reviewed the recommended contract with CIRMA for liability insurance. He noted that contract cost was under the FY2024 budget and provided the benefit of a 3-year rate stabilization agreement. Insurance consultant, Jason Guerrera of USI Insurance, provided additional review and comment. After discussion and review, motion to authorize the First Selectwoman to execute the contract for renewal with CIRMA for LAP as discussed. Motion moved by Mr. Tartell, seconded by Mr. Cole and carried 5-0.

- Vendor Selection and Possible Contract Merwin Meadows Playground Ms. Vanderslice noted 4 bids were received for the proposed playground at Merwin Meadows. Two bids were disqualified. One for late submission and one was incomplete. She shared the Parks and Recreation recommended Creative Recreation among the two qualified bids and requested approval from the board for the First Selectwoman to execute a contract to be prepared with Creative Recreation by Town Counsel in the amount of \$175,000. Motion to allow the First Selectwoman to execute a contract with Creative Recreation for the playground at Merwin Meadows. Motion moved by Ms. Healy, seconded by Mr. Nabulsi and carried 5-0.
- Appointments Economic Development Commission
 Ms. Vanderslice reviewed. After review, motion made by Mr. Cole seconded by Ms.
 Healy to appoint Donna Peterson and Joe Favarolo to the Economic Development
 Commission. Motion seconded by Mr. Tartell. After further discussion and review,
 motion carried 5-0.

D. Selectmen's Report

- 1. First Selectwoman
 - Update State Lease for Allen's Meadow
 Ms. Vanderslice noted the new lease must be approved by a special town meeting vote with an expected date in September.
 - CT Siting Council Public Hearing for Verizon Tower Public Comment-June 29th 6:30pm.
 Ms. Vanderslice updated the board with a reminder that the public hearing on the Verizon Cell tower proposal is in the final stages of being reviewed by the CT Siting Council. Zoom meeting is on June 29, 2023. Evidentiary hearing at 2:00pm with Public Comment beginning at 6:30pm
 - Ms. Vanderslice noted OPM had recently released FY2022 data for new residential housing permits Wilton ranked 7th highest in the state. She noted Fairfield County again led in the state and she recognized the work of the Wilton Planning & Zoning Commission members.

Key findings

- The Sister City initiative is new launched in January 2023 and is expanding
- Each municipality thought it was a great idea:
 - Tremendous support from the local citizens (Stamford & Westport have large Ukrainian heritage populations)
 - No perceived risk
 - Patriotic: Help Ukraine fight to maintain Democracy against Russian aggression
- First Selectperson/Mayor defines the relationship
 - Agreement is usually defined through a proclamation/statement or communication from the First Selectperson/Mayor No formal procedure exists
 - Town Council/Board of Selectmen do not need to approve. (Stamford Board of Representatives gave approval)
- The municipality partners with a local group of private citizens (steering committee) and supports communication.
- All fundraising activities and charitable donations are organized by local volunteers. Funds flow through Ukraine Aid International. The municipality has no financial involvement.
- Ukrainian Sister City documents results of all fundraising activities

Representative Quotes

First Selectwoman Nestor (Weston)

- The town is not obligated...no dollars touch the town. We only do things that are free.
- The steering committee is Weston volunteers
- I have the same relationship (with the Sister City Mayor) as I do with Jen Tooker

First Selectwoman Kupchick (Fairfield)

- There was no need to clear it...it is just a partnership
- The community is very excited. The steering committee does all the work.
- The town is not contributing, we simply are a sister city we are promoting a sister city
- I don't see any downside. It is only feel good and nice...It's all about helping a country fight for Democracy.

Selectwoman Tooker (Westport)

- Westport was the first to sign on in November/December (2022)
- (Westport became involved) two young men, who are Westporters came to me and explained.
 We know the President & COO of UAI. They are both Westporters.

Mission: Ukraine Aid International

The world has come together to bring aid to Ukraine.

Last mile delivery is the biggest need for 2.5 million civilians still living near the front lines of the war.

Front line communities face similar challenges:

- · Poor or nonexistent utilities: electricity, heat, clean water, internet
- · Destroyed bridges, roads, and lack of critical infrastructure
- Devastated private homes, with some neighborhoods over 90% destroyed by shelling
- Lack of reliable commercial shipping routes
- Small working age population with a lot of elderly and children who need help

These problems make it difficult if not impossible for humanitarian aid donated from all over the world to reach the civilians who need it most.
